HOW TO ENTER

These rules govern INVEST IN OUR VETERANS ("Contest"), which is being conducted by KIRO-AM ("Station"). The Contest begins on May 27th, 2024 and ends on October 30th, 2024 ("Contest Dates"). Entrants may enter on-line only.

To enter the Contest, entrant may enter on-line beginning on May 27th, 2024 at 12:00 AM PST and ending on October 30th, 2024 at 11:59PM PDT ("Entry Period").

i. Beginning May 27th, 2024, and continuing until approximately 11:59 p.m., PDT, October 30th, 2024, Contestants can mail their entry to "Invest In Our Veterans" at 1820 Eastlake Avenue East, Seattle, Washington 98102 or submit the entry online through the Site. Submissions must include a short essay (the "Essay") which should contain 500 words or less and tell the Station and Global Credit Union how the nominated organization has made an impact on Veterans, activeduty servicemen and women and their family's lives, the community impact, and why it deserves this donation. Contestants can also enter the Contest by completing the "Invest in our Veterans" nomination form at www.mynorthwest.com/veteran, beginning the first date of the entry period. Submissions must be accompanied by the following information:

- c. Only one (1) entry per person is permitted. There will be up to a total of four (4) organizations selected in the Contest.
- d. The Station may discard any entries that it deems suspicious, objectionable or in poor taste, as determined by the Station in its sole discretion.
- e. All entries must be received by the end of the Entry Period.

ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Washington, eighteen (18) years of age or older, and who reside in one of the jurisdictions that make up the listening area in and around Seattle, Washington. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station Contest at any time, even if such individuals meet the age and residency requirements above: (i) any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) any immediate family members of such employees, including, without limitation, current and/or exspouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) any other individual legally residing in the same household (i.e., at the same address) of such employees, including, without limitation, roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, persons who have previously won a donation (cash, services, merchandise) from a Contest or Station event from any of the Bonneville Seattle Radio Stations are subject to the following restrictions:

Persons who have won a sixty (60) days prior to entering the Contests are not eligible to participate. These restrictions also apply to immediate household members of Contest or Recipients.

- d. To claim this donation, the Recipient must provide valid government-issued photo identification and provide their complete address, date of birth, phone number, email address and Social Security Number.
- e. Entrants are required to provide truthful information and the Station will reject and delete any Submission that it discovers to be false or fraudulent. The Station will disqualify any Entrant who does not meet the eligibility requirements and will also delete any Submission as required by law.
- f. This Contest is subject to all applicable federal, state and local laws and regulations. By participating in the Contest and/or acceptance of donation(s), Entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

DONATION

Four (4) donations will be awarded. Each donation consists of \$1,000 for each selected organization. The Approximate Retail Value ("ARV") of the donation(s) is \$1,000. The organization will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the donation.

Donations are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a donation of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the donation. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station/judges are final.

If due to a printing, production or other error, more donations are claimed than are intended to be awarded for any donation level; the intended donation will be awarded in a random drawing from among all verified and validated donation claims received for that donation level. In no event will more than the stated number of donations be awarded.

JUDGING CRITERIA

A judging panel consisting of Bonneville Seattle and Global Credit Union employees will judge the Essay ("Judges"). The Judges will select four (4) organizations from among all eligible entries based on the following criteria ("Judging Criteria"): (1) the impact on Veterans and active-duty servicemen and women and their families (60%); and (2) the impact on their community (40%).

TIE BREAKER

In the event of a tie for a donation, the tie breaker will be determined by a random drawing from all tied potential Recipient(s) by the Contest Sponsor. The Contest Sponsor, at its sole discretion, shall make the final decision to resolve any tie.

RECIPIENT SELECTION AND NOTIFICATION

Decisions of the Station management with respect to the Contest are final.

Four (4) Recipients will be selected as described above.

Odds of receiving a donation depend upon the number of entries.

Recipients do not need to listen to the Station or be present to receive donation. All Recipients will be contacted later to arrange for donation pickup. If a Recipient chooses to have a donation shipped, the Recipient will be required to sign a release that the Station and any Released Parties (defined below) are not responsibility if the donation is late, lost, stolen, misdirected, undeliverable, or damaged during shipping. In such cases, there is no purchase necessary to enter or receive donation, except for reasonable postage and handling fees the amount of which shall not exceed \$1.50 plus the actual cost of postage to ship the donation.

Potential Recipients(s) will be notified of donation by email or a phone call. Donations(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. Upon notification or notification attempt, the potential Recipients(s) will be required to respond to such notification attempt and must execute and return, along with the guest(s) of the Recipients(s), an affidavit of acceptance, eligibility, liability, publicity release, and if applicable, Contest Sponsor liability release forms within thirty (30) days of such notification or notification attempt or donation(s) will be forfeited. If a Recipient has not reached the age of majority in his/her state of residence, the donation(s) will be awarded in the name of his/her parent or legal guardian. If a potential Recipient(s) is deemed ineligible for any reason, cannot be contacted, fails to sign and return the fully-executed affidavit of eligibility and/or liability/publicity release within the required time period, or if a donation or donation notification is returned as undeliverable, the potential Recipient forfeits the donation(s). The Station or Contest Administrator or Sponsor is not responsible for any changes in an entrant or Recipient's email address, phone number, mailing address or other contact information.

CONDITIONS

THIS CONTEST IS VOID WHERE PROHIBITED. Entrants agree that this Contest shall be subject to and governed by the laws of the State of Washington and the forum for any dispute shall be in Seattle, Washington. To the extent permitted by law, the right to litigate, to seek injunctive relief or to make any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Contest are hereby excluded and any Entrant expressly waives any and all such rights. Certain restrictions may apply. Submissions are void if the Submissions are incomplete, inaccessible or blocked, corrupted, damaged, irregular, altered, counterfeit, produced in error or obtained through fraud or theft.

By entering and/or acceptance of donation(s), Entrants also agree (i) to be bound by these Official Rules; (ii) that the decisions of the Station and Contest Sponsor are final and binding with respect to all matters relating to the Contest; and (iii) if the Entrant receives the donation that Released Parties (defined below) may use the Recipients photographs and each Recipient's name, photograph, likeness,

and/or voice in any publicity or advertising relating to the Contest or future promotions without compensation or approval (except where prohibited by law).

The use of any device to automate entry is prohibited. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, promotion entry services or proxies) will void all entries by that entrant at the Station's discretion. The Station's or its Contest Administrator's computer or telephone system is the official time keeping device for this Contest. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any donation or donations. If the Station makes a good-faith determination that an entrant has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that entrant from entering and/or receiving this donation and any or all future Station-administered Contest and seek damages to the fullest extent permitted by law.

The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the Contest, including, without limitation, the substitution of a donation(s) of equivalent value, which will become effective upon announcement. To the extent the Station makes material changes to the terms and conditions of the Contest, any such material changes will be broadcast on the Station and/or posted on its website: www.mynorthwest.com/veteran within twenty-four (24) hours of the change and periodically thereafter. If due to circumstances beyond the control of the Station, any competition or donation-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the Contest and shall not be

required to award a substitute donation(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.

Calling the Station regarding the Contest constitutes permission for the Station to tape the caller's voice and use it on the air. All telephone calls during the Contest may be taped without further permission from the caller. By entering the Contest and/or acceptance of donation(s), all entrants consent to the use of their name, photograph, likeness, biography, voice, video, entry materials, donation information (if any), or any statements made for trade, publicity, advertising, or promotional purposes, in any and all media, now known or hereafter devised, including online announcements, without limitation and without compensation, except where prohibited by law.

Each Recipient will be required to produce identification satisfactory to the Station. For example, Recipient(s) will be required to sign an affidavit of eligibility and release, including a publicity release, as prepared by the Station prior to receiving their donation. Each Recipient will solely be responsible for any (federal, state, or local) taxes or fees that result from the receipt and/or use of their donation and may receive an IRS Form 1099-Misc for all donations received from the Station in any calendar year where the aggregate value of all such donations is \$600 or more. The Contest is void where prohibited by law. Failure to comply with the terms and conditions applicable to Contest entry, including without limitation submitting an incomplete or fraudulent entry, and/or failing to complete the entry process, will result in such Entry being disqualified from such Contest. Any individual(s) that is found to be, or suspected of, tampering with a Contest in any way, including without limitation by making a fraudulent entry, by engaging in any "deal-making" with or between other Contest entrants or third parties, by creating a public hazard, by cheating, by engaging in improper or illegal activity, by causing interference with or the destruction of property and/or utilized public safety resources will be disqualified from participating and/or receiving any donations and/or prize(s), as applicable, and may be banned from any future participation in any Contest as determined by Station at its sole discretion and on a case-by-case basis.

The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering, or the administration of the Contest or in the announcement of a donation; (ii) incorrect or inaccurate information, human error, failure, or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, illegible, incomplete, or late entries; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone service outages, delays, busy signals, poor signals, or signal interference, accidental disconnection, equipment malfunctions, and any other technological failures; or (vi) any cancellations, delays, diversions, or substitutions or omissions by any transportation providers or any other persons

or entities providing any services to Entrant(s) and/or Recipients(s) (and Recipient's guest(s) if applicable) including any results thereof such as changes in services or location necessitated by same; or (vii) any part of a Contest that cannot be conducted and/or if a donation, either in whole or in part cannot be awarded due to the closure of any Contest Sponsor location, if applicable, promoter or performer issues, acts of God, any action, regulation, order or request by any governmental or quasi-governmental entity (whether or not the action, regulations, order or request proves to be invalid), equipment failure, threatened terrorist acts, terrorist acts, air raid, blackout, act of public enemy, earthquake, volcanic eruption, war (declared or undeclared), fire, flood, epidemic, pandemic, disease, national or regional emergency, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal) labor or material shortage, transportation interruption of any kind, work slowdown, civil disturbance, insurrection, riot, or any other cause beyond the Station's sole control.

Facebook, or Instagram collects through an Submission in the Contest may be subject to Twitter's, Facebook's. or Instagram's own terms and policies.

RECIPIENTS' LIST/COPY OF OFFICIAL RULES

- a. Any violation of these rules will result in disqualification. Consistent with Section 1(d), only one (1) Submission per Entrant is permitted. Any attempt by any one or more Entrants to obtain more than one (1) Submission by using the same phone number, email address, Twitter account or similar registration method through any means including, without limitation, multiple/different email addresses, Twitter accounts, identities, registrations, logins or other methods will void all entries from that address or account, and such Entrant(s) will be disqualified.
